**PRESS RELEASE**

Islamabad; 8<sup>th</sup> April, 2019. 3<sup>rd</sup> meeting of the Standing Committee on Information Technology and Telecommunication was held in Committee Room No.7 (4<sup>th</sup> Floor), Parliament House, Islamabad with Mr. Ali Khan Jadoon, MNA in the Chair.

2. The Committee was given a detailed briefing on the PSDP 2019-20 reflecting the ongoing as well as the new projects of the Ministry of Information Technology and Telecommunication and its attached organizations. The Committee raised certain questions on the PSDP funded projects and desired province-wise break-up of the projects in the next meeting. Worthy Members asked the questions from representatives of the Ministry.

3. Regarding e-office, NITB briefed on levels (0 to 4) status they attained in the different Ministries. In level 2 they informed that they have updated National Assembly, Prime Minister Office, CDA, NEPRA, FBR, PARK, PEMRA, CGA, NTC, CCP, DRAP, NTDC, WWF and Federal Ombudsman Office with e-system. They further informed that there are certain Prime Minister Office directives regarding implementation of e-office with deadline for level 04. PC-I may be revised to complete remaining contractual obligations. In National Assembly 307 employees, digital certificate and profiles are created, provision of e-office application suite made since 2014, out of 335 employees 312 are trained and 20 out of 32 sections were automated. (Not using at present)

4. In briefing, PTA informed regarding mandate of PTA under legal provisions of Prevention of Electronic Crime Act (PECA 2016) the mandate of PTA to block/remove online content, fake accounts un-law fully operating. The procedure for complaints handling described since the Web Analysis Cell is constituted to receive/process complaints requiring internet content regulation. A standard operating procedure has been devised to execute the process in an effective manner.

5. In accordance with the SOP, complaints from individuals and stakeholder (Govt. Departments) requiring blocking/regulating web content of different categories including defamation/impersonation are received through an electronic portal, email and postal media. At present, thirty (30) Federal and Provincial government organizations are accessing e-portal for lodging their complaints. For lodging of complaints by general public, PTA has notified a dedicated email address i.e. info@pta.gov.pk. On receipt of a complaint, PTA issues necessary directions for blocking/removing of the alleged content to telecom licensees. In case, any content or fake account hosted on a secured platform like Facebook, Twitter and Youtube, the relevant administration is requested to remove the content/block the fake account. Since Laws of Pakistan don't apply on such platforms therefore they take action in accordance to their community standards.

6. Content Removal/Blocking for impersonation/fake account is concerned, PTA has processed 1684 such URLs/websites. Detail of URLs/Websites processed for blocking is shown in table:

7. It is informed that Ministry of Information and Broadcast (MoIB) has raised a Cyber Wing which reports about 71-fake accounts, defamatory/impersonation.

8. It is observed that Social Media Platforms promptly respond to their users instead of any government organization. In this regard, PTA has also run media campaign to educate SM Users about their rights in accordance to rules of SM, Global increase in cyber crimes is also witnessed in Pakistan, NR3C National Response Centre for Cyber Crimes (now CCW Cyber Crime Wing) was established in 2007 at Islamabad, Karachi & Lahore, CCW is the only Law Enforcement Agency to combat cyber crimes in Pakistan, Jurisdiction of CCW has been extended to cover the whole of the country, Cyber Crime Circles in Provincial Capitals plus 10 more stations. In Specialized wing of FIA, mandated for the Technology based Law Enforcement, Enforcement of PECA-2016, Cyber Crimes/Terrorism, Digital Forensics Laboratories and Capacity Building and Awareness.

9. The Cyber Crime Wing, Federal Investigation Agency (FIA) informed regarding total number of social media complaints category-wise with break-up in each section of offence/crime: Viz. Fake Profile, Un-authorized Access/Hacking, Harassment Contents, Defamation Contents, Threats/Threatening Contents, Stalking, Blackmailing, Anti-Law Enforcement Agencies and Pornography. The total number of complaints processed were 29577 and number of URLs provided by the complainant 34846 and so many contents are removed from each complaint category.

10.
